#### Introduction

In November 2018, Instituto de Crédito Oficial (ICO) issued a Fifth Social Bond aimed at financing small, medium or microenterprises located in economically underperforming regions of Spain with an emphasis on employment creation or employment retention. In October 2019, ICO engaged Sustainalytics to review the projects funded through the issued social bonds and provide an assessment as to whether the projects met the Use of Proceeds criteria and the Reporting commitments outlined in the Instituto de Crédito Oficial Social Bond Framework.

#### **Evaluation Criteria**

Sustainalytics evaluated the projects and assets funded from November 2018 to August 2019 based on whether the projects and programmes:

- 1. Met the Use of Proceeds and Eligibility Criteria outlined in the Social Bond Framework; and
- Reported the Key Performance Indicators (KPIs) for each Use of Proceeds criteria outlined in the Social Bond Framework.

Table 1 lists the Use of Proceeds and Eligibility Criteria, while Table 2 list the associated the KPIs.

Sustainalytics made all efforts to ensure the highest quality and rigor during its assessment process and enlisted its Sustainability Bonds Review Committee to provide oversight over the assessment of the review.

#### Conclusion

Based on the limited assurance procedures conducted, nothing has come to Sustainalytics' attention that causes us to believe that, in all material respects, ICO's Fifth Social Bond, issued to fund eligible projects through ICO's second floor facilities, is not in conformance with the Use of Proceeds and Reporting Criteria outlined in the ICO Social Bond Framework. ICO has disclosed to Sustainalytics that the proceeds of the social bond were fully allocated as of August 2019.
